FOREIGNER REGISTRATION REGULATIONS

- 4. Submit required documents to apply for study permit, namely:

- Statement of Regulatory Compliance & Non-Political Involvement in Indonesia (form provided by Universitas Ciputra Surabaya)
- 10. Unemployment Statement Letter (form provided by Universitas Ciputra Surabaya)
- 11. Legalized Bachelor & Master Degree and legalized transcript (1 sheet each) and DIKTI equivalency for overseas graduates
- 12. The application and process of study permit will be done by Universitas Ciputra Surabaya
- 13. After the study permit is issued by the Indonesian Ministry of Education and Culture, prospective students must re-register.


